## Community Grants Funds

**Community Grants Funds are also known as “unrestricted,” established by donors who wish to leave the distribution of grants to the discretion of Incourage Community Foundation’s Grants Committee. Unlike donor advised or designated funds, the donors do not specify certain organizations or causes as grant recipients.**

**Community Grants Funds allow Incourage to respond to local pressing and changing needs. The Grants Committee - comprised of community and Foundation representatives - reviews community opportunities and needs, as well as requests from local nonprofit organizations, in order to determine grants in the areas of health and human services, arts and culture, education, and community improvement - to name just a few.**
