3-O Day Scholarship

Description

3-0 Day (Our Bodies, Our Selves, Our Responsibilities) had its beginning in 1977 largely due to the efforts of Rev. Roger Brooks, a minister with the United Church of Christ in Nekoosa. In talking to physicians, school personnel, other ministers, and parents, it became clear that there existed a growing awareness and concern regarding teen pregnancy. As a result, representatives from south Wood County, including a group of private and public social service people, school personnel, clergy, nurses and doctors, and parents was formed to discuss the issue. In the fall of 1979, the group incorporated and formed a board of directors.

Since incorporating, the 3-0 Day Board realized that area youth faced a large number of challenges that impacted their overall wellbeing. To that end, the Board provided an annual one day seminar, offering a variety of workshops aimed at enhancing student total wellbeing. Students from over 20 schools throughout south Wood County and beyond attended this event, with the last event being held in 2022.

The 3-0 Day Board has come to recognize that topics in student physical, social, mental and emotional health are now being covered in the schools. As a result, the board has agreed that the funds remaining can be best used to fund scholarships for students pursuing careers in mental health fields. The mission of 3-0 Day has always been to educate youth so they make responsible decisions that help them to lead healthy and productive lives. This scholarship will continue that mission into the future.

John Akey Memorial Scholarship

Description

John was employed with the U.S. Postal Service for 34 years. During that time, he was the Wausau Area Local Union President for 21 years and was president of the Wisconsin American Postal Workers Union for 12 years.

Joyce Richards, retired president of APWU Wisconsin, remembers John as a mentor and friend. "As we each tuck John into that special place in our hearts, we must remember all of his examples, both serious and mischievous. As the new and young ones enter John's beloved union you must take them under your wing and teach them well as John did," says Richards.

"John had a way of making us feel there was a bright side to everything, and to hang in there as it would no doubt get better," says Bill Sparks, President of Northeastern Wisconsin Area Local, APWU.

Children's Choice Elementary School opened in the fall of 1890, with an enrollment of 22 children. Known to everyone as District No. 4, the little school on the corner continued to give the three "R's" to children for many years. In 1917, District No. 4's parent organization asked its members to submit potential names for the school. Mrs. Gilbert Moll submitted "Children's Choice School," which was accepted. In June 1949 construction began on a new building, which was designed to accommodate 150 children in six classrooms and a multi-purpose room.

Although Children's Choice School went through many changes since its doors opened in 1890, it continued to provide a quality educational experience for children until its closure in 2006. This scholarship was established by donations from Children's Choice families, PTC, staff, and alumni to honor a place that will be remembered by hundreds of students, families, and staff members as a wonderful place in which to work, learn, and play.

The last kindergarten class that attended Children's Choice Elementary School graduated from high school in 2018. With a strong belief in the power of education and the need for dedicated, quality teachers, Children's Choice PTC committee members (John Benbow, Timothy Bruns, Diane Glodosky) revised the focus of the scholarship in 2021 to support students pursuing a teaching career in K-12 education.
